

R Rentals – End-User License Agreement (EULA)

- Automatic recurring payments, if enabled, will be processed via QuickBooks Payments.
- Late or failed payments may result in restricted access to your storage unit.

5. Termination

We reserve the right to suspend or terminate your access to the Services without notice if:

- You breach this Agreement.
- You fail to make timely payments.
- You engage in fraudulent or abusive behavior.

6. Limitation of Liability

To the fullest extent permitted by law, R Rentals shall not be liable for:

- Loss, theft, or damage to items stored within your unit.
- Service interruptions, data loss, or unauthorized account access.
- Any indirect, incidental, or consequential damages arising from use of our Services.

7. Indemnification

You agree to indemnify and hold harmless R Rentals, its owners, and employees from any claims, damages, or liabilities arising from your:

- Use of the Services.
 - Violation of this Agreement.
 - Storage of prohibited or illegal items.
