

R Rentals– Terms of Service

- Payments are processed securely through QuickBooks Payments.
 - By providing payment details, you authorize us to:

 - Process recurring payments if you enable autopay.
 - Late payments may result in:
 - Restricted access to your storage unit.
 - Late fees as outlined in your rental agreement.
 - Possible lien proceedings as permitted by state law.

5. Prohibited Storage Items

You may not store any of the following:

- Hazardous or flammable materials.
- Illegal drugs, firearms, or stolen property.
- Perishable goods that attract pests.
- Any items prohibited by state or federal law.

Violation of this section may result in immediate termination of your rental agreement and possible legal action.

6. Facility Access

- Access to your unit is granted through your unique gate code.
 - Sharing your access code with unauthorized parties is strictly prohibited.
 - We are not liable for unauthorized access caused by your negligence.

7. Service Availability

- We strive to maintain uninterrupted access to our website, portal, and storage facilities.
- However, we do not guarantee continuous service and may temporarily suspend access for:
 - Maintenance or upgrades.
 - Security issues.
